Firm no. 2 was failed in the detail technical proposals evaluation on account of seven (7) proposed key expert's CVs are not in the required format. Therefore, the experts were disqualified based on Section 2 Instruction to Consultants and Data Sheet, F. Disqualification of an Expert, item no. 3.

Furthermore, the firm no. 5 failed in the detail technical proposals evaluation as a consequent of firm does not have any similar experiences in the required services in the last ten (10) years.

3. Evaluation Price Proposal and Price Score

The contract for this assignment is a Lump Sum contract and as indicated in RFP, Section 2, ITC 23.2, the consultant is deemed to have included all prices in the Financial Proposal and addendum no. 1 issued on 08 June 2024.

So, neither arithmetical correction nor price adjustment shall be made. The total price specified in the Financial Proposal (Form Fin -1) shall be considered as the offered price.
